### PURPOSE OF DATA PROCESSING

The data processing relating to the web services of this site are only handled by technical personnel or by eventual personnel in charge of occasional maintenance operations.

### DATA PROCESSING METHOD

### DATA STORAGE PERIODI

Personal data is processed by automated tools for the time strictly necessary to achieve the purposes for which it was collected.

### RIGHTS OF THE INTERESTED PARTIES

At any time, the individuals to whom the personal data refers to have the right to obtain the confirmation of the existence of such data and to know its content and origin, verify its accuracy or asks for its integration or updating and rectification.

Furthermore, the interested party has the right to ask for the cancellation, the anonymous transformation or the blocking of the data illegally processed, as well as to oppose in any case for legitimate reasons to its processing.

Finally, the interested party can file a complaint to a supervisory authority.

The requests should be addressed to the Data Controller to whom information about the Data Protection Officer (DPO) may be asked for.
